Dealer Terms and Conditions

Please indicate agreement with the HVIP Terms and Conditions by signing below:

1. I agree to meet and follow the requirements and responsibilities for dealer participation in the HVIP identified in this agreement and the HVIP Implementation Manual and will continue to do so throughout my participation in the program;
2. I have and shall maintain at least one (1) employee that has successfully completed training by CALSTART regarding the terms, conditions, and requirements of the HVIP;
3. I understand that a voucher request or redemption form which is incomplete, illegible, or missing required documentation will be immediately rejected and returned to me;
4. I understand that I can reapply for HVIP funding if a voucher request is rejected because it is incomplete, illegible or missing required documentation;
5. I understand that the HVIP has limited funds and that voucher redemption is contingent upon availability of program funding;
6. I agree to provide accurate information regarding the HVIP to purchasers and to assist purchasers in correctly completing their portion of the voucher request and redemption forms;
7. I agree to ensure that the vehicle, engine, or conversion purchase price is reduced by the approved voucher amount prior to selling the vehicle, engine, or conversion;
8. I understand that I am responsible for ensuring that all vehicle, engine, or conversion and purchase information is complete and accurate;
9. I agree to be available for a follow-up inspection by the California Air Resources Board (ARB), CALSTART, or their designee, if requested;
10. I agree to keep written records of the purchase for three years after the purchase date and provide ARB or its designee with these records within ten days of their request. These records include but are not limited to the invoice, proof of purchase, California Department of Motor Vehicle records, payment information and related bank records, and purchaser fleet information; and
11. I understand that ARB has the right to ban any dealer from future participation in the HVIP and pursue any other legal remedies for failure to meet these terms and conditions or other applicable requirements of the HVIP.
